Rockschool & Flight Ukulele Classroom Competition Terms & Conditions

By entering the Ukulele Classroom Competition 2021 (**'Competition'**) the Entrant (as hereinafter defined) agrees to be bound by the terms and conditions set out below (**'Terms & Conditions'**).

1. Definitions:

a. **'School'**

This is the school nominated to win the major prize pack. The school can be either a primary or secondary school (public or private) OR an independent music school anywhere in Australia or New Zealand.

b. **'Entrant'** or **'Registering Adult'**

This is the person:

- i. that is entering the Competition and if selected will win the prize for their nominated school, and
- ii. is bound by the Terms & Conditions.

The Entrant must be:

- iii. the teacher aged 18 or above; or
- iv. a student, who if under the age of 18 must have the assistance and provide the contact details of a 'Registering Adult' to enter. A 'Registering Adult' can be the Entrant's parent, legal guardian, family member or teacher over the age of 18.

c. **'Intellectual Property'**

3. To enter, entrants must tell us in 50 words or less how would winning a class set of Flight Ukuleles and Rockschoool Ukulele books impact your school music program? Entrants are encouraged to send a photo to accompany the reasons given in their written entry. Schools may be nominated multiple times. These requirements plus all other compulsory

sections of the entry form hosted on rockschool.ameb.edu.au/ukulele-competition must be completed for the entry to be valid.

4. The competition opens at 9am AEDT on Monday 28th June 2021 and closes at 9am AEDT on Monday 26th July 2021. Entries received by the Promoter after this time, or incomplete or deficient Entries, whether by reason of error, omission, tampering, theft, destruction, force majeure or otherwise, will not be considered.
5. The prize given to the winner:

6. The winner/s will be selected by a panel of expert judges appointed by the Promoters, at their absolute discretion. Judges will assess the written answer and supporting image (if provided) in combination. The judges' decision is final and conclusive, and no further review or correspondence shall be undertaken. The Entrant agrees not to publish any adverse comments in relation to the judges or the judging processes.

7. Judging Criteria

Judges will be basing their assessment of the entries around the following points:

- Creative flair to written or pictorial response

- Demonstrates a dedication or desire for music in the school community
 - Demonstrates the school's need for equipment and instructional material
8. Entrants will not receive the judges' assessment of their performance and no feedback will be provided.
9. Entry is open to students and teachers at qualifying schools in Australia and New Zealand subject to all other requirements under these Terms & Conditions.
10. Winners will be notified by phone and in writing, and their names published at rockschool.ameb.edu.au/ukulele-competition no more than two weeks following the close of the competition.
11. Prizes shall be claimed in coordination with Hal Leonard and AMEB. Such coordination will be initiated by Hal Leonard and AMEB after the announcement of the prize winners. If any prize has not been accepted or claimed within 30 days, the relevant winner's entry will be deemed invalid and the Promoters may award the prize to another Entrant.
12. By uploading an image on the competition landing page, the Entrant assigns absolutely to the Promoters all its right, title and interest, including all Intellectual Property rights, in and to the image, and the Entrant agrees that the Intellectual Property rights in and to the image will become the property of each Promoter severally. The image may be copied, reproduced and/or published online/offline to promote the Competition, and/or any other initiative, at the sole discretion of the Promoters. By entering this competition, Entrants consent to any and all acts or omissions (whether occurring before or after this consent is given) in relation to their Entries, which might otherwise infringe the Entrant's moral rights (as defined in the *Copyright Act 1969 (Cth)*) in those Entries.

13. Entrants warrant and represent to the Promoters that the Intellectual Property in images and words comprising their Entry or Entries, and their use by the Promoters in accordance with these Terms & Conditions, do not infringe the Intellectual Property rights of any other person.
14. Entrants agree to indemnify and hold harmless each Promoter (**'Indemnified'**) in respect of any loss, costs, expenses or damage arising from any claim suffered or incurred by the Indemnified in respect of any breach of these Terms & Conditions.
15. Personal information collected in the administration of this competition will be securely stored by and may be used in the marketing efforts of both AMEB and Hal Leonard. No information will be shared with or sold to any other party except to facilitate the running of the competition or the provision of prizes. Participants may at any time request a copy of any personal data from AMEB or Hal Leonard.
16. The Promoters may require winners to provide proof of identity, age, residency, or enrolment at the nominated school. Identification considered suitable for verification is at the Promoter's discretion.
17. The Promoter may, in its sole discretion, disqualify all Entries from, and prohibit further participation in this Competition by, any person (including without limitation a winner) who tampers with or benefits from any tampering with the entry process or with the operation of the Competition or acts in violation of these Terms & Conditions, acts in a disruptive manner or acts with the intent or effect of annoying, abusing, threatening or harassing any other person or behaves in a manner which may diminish the good name or reputation of the Promoters or any of their related bodies corporate or the agencies or companies associated with this Competition, is contrary to law or is otherwise inappropriate.
